- Fill in the required information in the NCSA ANIMATION LICENSE AGREEMENT below, as discussed and agreed upon.
- Email the license to otm@illinois.edu
- OTM will review the license and will send you the final approved version or will contact you.
- Sign the final approved license agreement using the appropriate company officer signature. The OTM does not accept digital signatures but does accept scanned wet-ink signatures in PDF format.

# NCSA ANIMATION LICENSE AGREEMENT

This license agreement ("Agreement") is made as of the date of last signature below ("Effective Date") between The Board of Trustees of the University of Illinois ("University"), a body corporate and politic organized under the laws of the State of Illinois, with principal offices at 352 Henry Administration Building, 506 South Wright Street, Urbana, Illinois 61801, U.S.A., and ("Producer"), a company with a principal place of business at, and ("Company"), a company working
with Producer with a principal place of business at(Producer and Company collectively referred to as "Licensees").
WHEREAS, University, through its National Center for Supercomputing Applications ("NCSA"), located on University's Urbana-Champaign campus has produced computerized visualization animations based on scientific simulations of the images further specified in Attachment A ("Images"), (attached hereto and incorporated herein by reference); and
WHEREAS, Producer is interested in utilizing Images in producing a film or video production presently entitled "" on behalf of the Company, (the "Production"); and
WHEREAS, University is willing to provide the Images to Licensees for use in the Production, subject to the terms and conditions of this Agreement.
NOW, THEREFORE, in consideration of the mutual promises and covenants contained herein, the parties hereby agree as follows:
1. <u>Copyright Ownership</u> . University created the Images, and The Board of Trustees of the University of Illinois owns the copyright in the Images. Nothing herein shall be deemed as an assignment or transfer of any copyright or other proprietary rights to Licensees.
2. <u>License Grant</u> . Subject to and conditioned on Licensees' compliance with the terms and conditions specified herein, University grants to Licensees a non-exclusive, non-transferable, royalty-bearing, restricted license to (a) use and incorporate the Images into the Production and (b) reproduce copies of the Images as incorporated into the Production for distribution, sale, licensing, marketing, advertising, promotion, exhibition and other commercial exploitation of the Production. Licensees agree that all copies of the Images made by or on behalf of Licensee shall contain the same content as the original Images supplied by NCSA to Licensees, except as provided in Section 5 below. NCSA will deliver the Images to Licensees in this format:
3. <u>License Restrictions</u> . Except as expressly set forth in Section 2 above, Licensees shall not: (a) broadcast, sell, lease, license, or distribute the Images except as incorporated into the Production; (b) modify or make derivative works of the Images. Should Licensees desire additional rights other than those granted under Section 2, Licensees shall contact University to request a license for additional rights. Nothing in this Agreement shall be construed as conferring any license under any of University's or any third party's intellectual property rights, whether by estoppel,

implication, or otherwise, except for the limited rights and licenses expressly granted in this Agreement.
4. Payments. In consideration of the license rights granted herein, Licensees shall pay to University an upfront royalty payment of
bank fees connected to a payment shall be paid by the Licensee.
5. <u>Acknowledgements, Copyright Notices, and Use of Names</u> . Licensees shall include the following acknowledgement and copyright notices when displaying the Images:

© Copyright 20 The Board of Trustees of the University of Illinois.
Except for the above acknowledgement and copyright notice, Licensees shall not use any name, trade name, trademark or other designation of the University (including any contraction, abbreviation or simulation of the foregoing) in advertising, publicity or other promotional activities.
6. Term and Termination. This Agreement shall become effective as of the Effective Date and shall remain in effect in perpetuity unless earlier terminated as specified below. Either party may terminate this Agreement as specified herein if the other party commits a material breach of this Agreement. If the breach cannot be remedied, then the non-breaching party may terminate this Agreement immediately upon notice to the breaching party. If the breach is capable of being remedied, then the non-breaching party must provide written notice of the breach to the breaching party. If the breaching party fails to cure such breach within ten (10) days after receiving such written notice, then the non-breaching party may terminate this Agreement, or specific rights and licenses granted under this Agreement, immediately upon providing written notice of termination to the breaching party. Within ten (10) days of termination, Licensees shall (i) return or destroy all materials furnished pursuant to Section 2 above to University at Licensees' expense; and (ii) certify in writing by an officer of Licensees that such materials were so returned or destroyed. The provisions set forth in Sections 1, 7, 8, and 9 shall survive termination or expiration of this Agreement.
7. <u>Disclaimer of Warranties.</u> TO THE FULLEST EXTENT PERMITTED BY APPLICABLE LAW, UNIVERSITY PROVIDES THE IMAGES "AS IS" AND DISCLAIMS ALL EXPRESS OR IMPLIED CONDITIONS, REPRESENTATIONS AND WARRANTIES, INCLUDING WITHOUT LIMITATION ANY IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, OR NON-INFRINGEMENT. Licensees shall not

make any statements, representations or warranties whatsoever with regard to any person or entity that are inconsistent with the disclaimers set forth in this Section 7.

8. <u>Limitation of Liability</u>. In no event shall University or its affiliates (including its trustees, directors, officers, faculty, staff, students, employees, consultants, and agents) be responsible or liable for any indirect, special, incidental, punitive, consequential or other damages whatsoever (including lost revenue, profits, use, data, or other economic loss or damage), however caused and regardless of theory of liability (whether for breach or in tort, including negligence), in connection with, arising out of, or related to this Agreement, even if University has been advised of the possibility of such damages. Liability for such damages shall be limited and excluded as set forth herein, even if any remedy provided for in this Agreement fails of its essential purpose. Licensees shall not make any statements or accept any liabilities or responsibilities whatsoever with regard to any person or entity that are inconsistent with the limitation set forth in this Section 8.

### 9. Miscellaneous.

- a. Governing Law. This Agreement will be governed by and construed in accordance with the laws of the State of Illinois, without reference to its conflict of laws provisions. The parties agree that any action shall be brought and venued exclusively in the state courts within the State of Illinois.
- b. <u>Enforcement</u>. If for any reason a court of competent jurisdiction finds any provision of this Agreement, or portion thereof, to be unenforceable, that provision of the Agreement will be enforced to the maximum extent permissible so as to effectuate the intent of the parties and the remainder of this Agreement will continue in full force and effect. Any express waiver or failure by either party to promptly enforce any provision of this Agreement will not create a continuing waiver or any expectation of non-enforcement of that or any other provision.
- c. <u>Assignment</u>. This Agreement shall not be assigned, by operation of law or otherwise, by Licensees without the University's prior written consent.
- d. <u>Amendment</u>. This Agreement may not be modified or amended, in whole or in part, except by the execution of a written instrument signed by an authorized representative of each party.
- e. <u>Entire Agreement</u>. This Agreement, including any appendices or exhibits, embodies the entire agreement and understanding of the parties with respect to the subject matter hereof, and shall supersede all prior or contemporaneous agreements, representations, statements, communications and understandings, either verbal or written, between the parties relating to such subject matter.
- f. <u>Independence of the Parties</u>. Nothing in this Agreement shall be construed as creating a partnership, franchise, joint venture, agency or employment relationship between the parties. In all of their operations hereunder, Licensees shall be independent contractors, shall conduct their business at their own cost and expense, and shall have no authority to make any representations or warranties on behalf of University or to otherwise bind or incur any obligation on behalf of University.
- g. <u>Export Controls</u>. Images may be subject to U.S. export control laws and may be subject to export or import regulations in other countries. Licensees agree to strictly comply with all such laws and regulations and acknowledge they have the

- responsibility, at their own expense, to obtain such licenses to export, re-export, or import as may be required.
- h. <u>Counterparts/Facsimiles</u>. This Agreement may be executed in multiple counterparts, each of which when taken together shall constitute one and the same instrument. The parties agree that duplicated or facsimile signatures shall be deemed original for all purposes.
